**NOTIFICATION**

The following is the Ranked List of candidates for the post of **LD TYPIST ( BY -TRANSFER) IN VARIOUS DEPARTMENTS in THRISSUR DISTRICT (Category No. 281/2018) on Rs. 19,000- 43,600/-** found suitable by the Commission and arranged in the order of merit based on the marks secured in the OMR Test held on 06.07.2019. This **Ranked List is brought into force with effect from 10/11/2020**

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the Rules and Orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the List. In case the candidates included in the Ranked list could not secure appointment before the expiry of ranked list , the names of such candidates will be included at the top of the new ranked list of the low paid Employees drawn up by the commission subsequently in the same order and they will be advised for appointment accordingly.

candidates who have secured forty percent (40%) marks and above in the OMR test are included in the list and there is no candidate to be appended from previous Ranked list for the post

**NOTE (1) :-**

Since a common OMR test with common candidates was conducted for this post,the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists ( including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

**NOTE (2) :-**

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to The District Officer, Kerala Public Service Commission District Office, Thrissur- 680001. Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date on which this ranked list is uploaded in the Commission's website. The last date for receipt of applications is 15..01.2021 The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not

be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

**NOTE (3) :-**

Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to The District Officer, Kerala Public Service Commission District Office, Thrissur - 680001 within 45 (Forty Five) days from the date on which this ranked list is uploaded in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 15.01.2021. Applications received after the prescribed date will not be entertained.

**NOTE (4) :**

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (5)**

The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of Ranked List for the posts included in the common test held on 06/07/2019.
