Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate(in Form III /Digitally signed Certificate)and candidates belonging to other reservation communities are required to produce NCLC as per **G.O.(P) No .81/09/SC/ST/DD dated 26/09/09** issued by the concerned Revenue Authority at the time of OTR verification.
