**NOTE (1) :-** The Ranked list will remain in force till the publication of a new Ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. The candidates included in this list will be advised against 10% of the vacancies reported to this office for the post. The rules regarding the reservation of appointment as contemplated in the General rules 14-17 of Part II of the KS& SSR 1958 are not applicable to this appointment. If sufficient number of candidates are not available to fill up the 10% reservation quota mentioned above, such vacancies will be filled up by the candidates included in the Ranked list prepared for open quota. In case the candidates included in the Ranked list could not secure appointment before the expiry of the Ranked list, the names of such candidates will be included at the top of the new Ranked list of the Low paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O(P) No.39/89/P& ARD dated 08.12.1989.

**NOTE (2):-** According to the existing procedure, revaluation of Answer Scripts is not allowed. But Answer Scripts will be rechecked to see that all the answers are valued and there is no mistake in the totalling of the marks. A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance. "Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered."

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.85/- (Rupees Eighty Five only) under the head of account "0051-PSC 105 State PSC 99-Examination Fee", addressed to **The District Officer, K.P.S.C District Office, Pathanamthitta-689645** should reach the office within Forty Five days from the date on which the Ranked List is published in the website of the Commission ie, on or before **30.01.2021**. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded. Applications for rechecking received from the candidates whose answer scripts have been invalidated will not be considered.

**NOTE (3):-** Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.335/- (Rupees Three hundred and thirty five only) by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800- State PSC - 99 other receipts**). The duly filled in application in the prescribed form (available from the commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to **The District Officer, K.P.S.C District Office, Pathanamthitta-689645** within 45 days from the date on which this ranked list is uploaded in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is **30.01.2021**. Applications received after the prescribed date will not be entertained.

**NOTE (4):-** "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."

**NOTE (5):-** The A part and B part of OMR Scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked List ie, on **09.05.2021**.

**NOTE (6):-** Since a common objective type (OMR Valuation ) test was held for this post, the marks awarded to the candidates included in the Ranked list and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of all the Ranked lists (including NCA Ranked lists) which will be finalized on the basis of the Common Test. The result of rechecking of OMR scripts will be intimated in due course. But Photocopy of the OMR will be issued only after the publication of all the Ranked Lists to be finalised on the basis of the Common Test for each posts.
