Note :- (6) If the documents produced by any candidate are found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed; but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **03-04-2019** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
