**NOTIFICATION**

The following is the list of candidates for selection to the post of **Women Police Constable (APB) (MSP) First NCA-LC/AI (Category No. 627/2017)** on 22,200-48,000/- in Police Department in Malappuram District, found suitable by the Commission and arranged in the order of merit on the basis of the result of the Objective Type Test (OMR Valuation) held on 10/11/2018, and the Physical Measurement and Physical Efficiency Test conducted on 27/11/2019.

The Ranked List is brought into force with effect from 17/12/2020. The Ranked List shall remain in force until candidates are advised and appointed against the NCA vacancies arose due to the paucity of candidates belonging to **LC/AI Community** during the currency of the Parent Ranked List published for the post on 07/06/2016 (Cat.No.198/2015) or one year from the date which the NCA Ranked List is brought into force whichever is earlier. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But answer script will be re-checked if prescribed fee of **Rs. 85/- (Rupees Eighty Five only)** is remitted in any one of the treasuries in the State under the head of account "0051 PSC-105 State PSC-99 Examination Fee". **The fee once remitted will not be refunded on any account.** The result of the rechecking will be intimated to the candidates from this office. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied therefrom. Applications submitted in any other manner will not be considered. Valid applications for rechecking of answer script along with the original chalan receipt for the prescribed fee addressed to the **District Officer, Kerala Public Service Commission, District Office, Malappuram** shall reach this office within 45 days from the date on which the Ranked List is uploaded in the Commission's Website, ie on or before 19/02/2021. Application for rechecking received after the stipulated time will not be entertained.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs.335/- (Rupees Three Hundred and Thirty Five only)** by way of chalan in any of the treasuries in the State (**Head of Account 0051 PSC-800 State PSC-99 other receipts**). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **District Officer, K.P.S.C District Office, Malappuram within 45 days from the date on which the Ranked List is uploaded in the Commission's Website, ie on or before 19/02/2021**. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is 19/02/2021. Application received after the prescribed date will not be entertained.

***“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions”. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”***
