Note:- (6) Candidates belonging to SC/ST communities shall upload in profile and produce in person the Community Certificate obtained from Revenue Authorities not below the rank of Tahsildar along with other documents at the time of verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **29-01-2019** will be issued to those candidates who apply for the same, remitting the prescribed fee after approval of the Ranked List. Script of no candidate who appeared for the OMR Test for this selection is invalidated.
