**NOTIFICATION**

The following is the list of candidates found suitable by the Commission and arranged in the order of merit on the basis of the Objective Type (OMR) Test held on 04.04.2018, Physical Measurement and Physical Efficiency Test held on 19.11.2020 & 20.11.2020 and Practical Test (T-Test+Road Test) conducted on 16.02.2021 for selection to the post of **FOREST DRIVER (Part I Direct Recruitment) in FOREST DEPARTMENT IN KANNUR DISTRICT** (Category No.120/2017). The Ranked List is brought into force with effect from 08.06.2021.

The ranked list shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But rechecking of marks will be done on payment of Rs. 85/- (Rupees Eighty five only). The fee should be remitted in any one of the treasuries in the State under the head of account **“0051 PSC - 105 State PSC- 99 Examination Fee”** and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website/ [www.keralapsc.gov.in](http://www.keralapsc.gov.in) / or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach the **District Officer, Kerala Public Service Commission District Office, Civil Station PO, Kannur - 670 002** within 45 days from the date on which this Ranked List is uploaded in the Commission's Website (on or before **09.08.2021**). The fee once remitted will not be refunded on any account. Applications for re-checking received after the stipulated time will not be entertained.

Candidates who wish to obtain a photocopy of their OMR answer Script (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- (Rupees Three hundred and thirty five only) by way of Chalan in any of the treasuries in the State (**Head of Account 0051 PSC-800 State PSC - 99 other receipts**). The duly filled up application in the prescribed form (available from the commission’s website) along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission District Office, Civil Station PO., Kannur - 670 002** within 45 days from the date on which the Ranked List is uploaded in the Commission's Website (on or before **09.08.2021**). A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Applications received after the prescribed date will not be entertained.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions” The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”

Note I :- Since a Common OMR Test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the Common Test.

The Result of Rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR Answer Sheets will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the Common Test.

Note II :- The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date of finalization of Ranked List ie, on **08.12.2021**.
