NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on **04/04/2018** and Physical Efficiency Test held from **24/11/2020** to **25/11/2020** and Practical Test held on **16/02/2021** for selection to the post of **Forest Driver** on **Rs. 19,000- 43,600/-** in **Forest Department** in **Ernakulam District** and arranged in the order of merit. The Ranked List is brought into force with effect from **08.06.2021**.

The ranked list shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 5 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Ernakulam -682016 within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Note 1 :

Since a common OMR test was held for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR Test relating to all candidates appeared for the test will be published only after the publication of the Ranked Lists which will be finalised on the basis of the Common Test.

Note 2 :

The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all posts finalised on the basis of the common test .

Note 3 :

Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** by way of chalan in any of the Treasuries in the State (Head of Account : **0051 PSC - 800 - State PSC -99 Other Receipts**). The duly filled in application in the prescribed form(available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission District Office, Ernakulam-682016** within **45 (Forty Five)** days from the date on which this ranked list is uploaded in the Commission's website. A copy of

the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **05/08/2021**. Applications received after the prescribed date will not be entertained.

Note 4 :

A period of 45 days time to apply for rechecking of answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's Website. The candidates can avail only one chance. "Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered".

The application for rechecking, along with original chalan receipt for the prescribed fee of **Rs. 85/-** under the Head of Account "**0051 - PSC - 105 State PSC 99 - Examination Fee**" addressed to the **The District Officer, Kerala Public Service Commission District Office, Ernakulam-682016** should reach the office on or before **05/08/2021**. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

Note 5 :

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."

Note 6 :

The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked lists included in the common test held on 04/04/2018.
