Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/Digitally Signed Certificate) obtained from revenue authorities not below the rank of Tahsildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority at the time of OTR Verification
