Note :- (6) SC/ST Candidates included in the List are required to produce Community Certificate (in Form III /Digitally signed) issued by the concerned Revenue authority and candidates belonging to other reservation groups should produce Non -Creamy Layer Certificate issued by Village Officer at the time of OTR Verification

Note :- (7) Copy of answer scripts of the OMR Test held on 06-07-2019 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER11(2)4933/19/EW dated 12/12/2019
