Note :- (5) Candidates belonging to Scheduled Caste/ Scheduled Tribe community included in the Probability List are required to produce **Community Certificate** in the prescribed format issued by the Revenue authority at the time of OTR verification. Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **01-12-2020** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
