Note :- (3) The candidates who have secured **16 (sixteen)** marks and above are included in the Unified List. The minimum marks for inclusion in the list of candidates belonging to various reservation communities have been lowered to ensure their adequate representation in the list.

Note :- (4) Candidates included in the Unified List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be intimated through SMS & Profile Message.

Note :- (5) A Dictation test will be conducted for candidates included in the Unified list and the Date,time and Venue of Dictation test will be intimated through SMS & Profile Message. .

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) SC/ST Candidates included in the Short List are required to produce Community Certificate (in Form III - Digitally signed) and candidates belonging to other reservation groups are required to produce NCLC issued by the concerned Revenue authority.

Note :- (8) Copy of answer scripts of the OMR Test held on **06-07-2019** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER II (2) 4933/19/EW dated 12.12.2019 .
