Note :- (6) Candidates belonging to Other Backward Classes included in this List who are required to produce Non Creamy Layer Certificate as per G.O(P) NO.81/09/SC/ST/DD dated 26.09.2009 along with the other documents at the time of verification in original documents. SC/ST candidates included in the Probability List are required to produce Community Certificate in Form III or online Community Certificate issued under Rule 4 of the Kerala (Scheduled Caste/Scheduled Tribes)Regulation of issue of Community Certificate Rules 2002 by the competent authority.

Note :- (7) Candidates who produce NCLC/CC in which name of community is noted different to that specified in SSLC should produce Gazette Notification regarding change in community.

Note :- (8) Copy of answer scripts of the OMR Test held on **06-07-2019** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
