### NOTIFICATION

The following is the ranked list of candidates for selection to the post of **Lower Division Clerk (Tamil & Malayalam knowing) II NCA-Dheevera** on Rs-19,000-43,600/- in Various Departments in Palakkad District, found suitable by the Commission on the basis of objective type test (omr valuation) and descriptive type test (OSM valuation) and arranged in the order of merit. This Ranked List is brought into force with effect from **29/01/2022** and will be valid until a candidate is advised and appointed against the noted NCA vacancy or 3 years from the date of publishing this Ranked List, whichever is earlier. This is the second NCA notification due to the non availability of the qualified candidates belonging to the above community in Palakkad District for the above mentioned post notified as per **Category No 92/2014**, published in the gazette dated **11.04.2014**, due to the paucity of candidate belonging to Dheevera community during the currency of the mother Ranked List for the post published on **04/12/2012**, as category number **305/2007**.

**NOTE (1) :-** Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

**NOTE (2) :-** The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from along with **prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the. District Officer, Kerala Public Service Commission ,District Office, Collectorate P O,Palakkad.** Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of uploading of Ranked List in Commission Website of the Ranked List (on or before **25/03/2022** The candidates can avail only one chance for re-checking . Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

**NOTE (3) :-** Candidates who wish to obtain Scanned image of their On Screen Marked Answer Sheets (Descriptive Type Test) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to the **.the District Officer, Kerala Public Service Commission , District Office, Collectorate P O,Palakkad.** within 45 (Forty Five) days from the date of uploading of Ranked List in Commission Website of the Ranked List. A copy of Scanned image mentioned above will be issued only once to a candidate. Copies of Scanned image mentioned above invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 25/03/2022. Applications received after the prescribed date will not be entertained.

**NOTE (4) :-** Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
