**NOTE (I)** :-The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier.

**Note (II)**:-According to the existing procedure, reevaluation and rechecking of answer sheets is not allowed.

**NOTE (III)**:- Candidates who wish to obtain image and tabulation sheet of their answer sheet relating to this selection shall remit fees of Rs.335/- (Rupees Three Hundred and thirty five only) per paper in any of the Treasuries in the State (**Head of account: 0051 PSC-800 State PSC-99-Other receipts**). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to **The Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram-4** within 45 days from the date on which this Ranked List is uploaded in the Commission's website(i.e; on or before **05.05.2022** ).Application received after the prescribed date will not be entertained. A copy of an answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**NOTE (IV)**:- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
