Note :- (6) Candidates belonging to Other Backward Classes included in this List are required to produce Non-Creamy Layer Certificate as [per GO(P)No:81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates included in this List ,are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar along with the other documents mentioned above at the time of verification of original documents. Candidates belonging to Economically Weaker Section(.EWS) included in this List are required to produce certificate issued by the concerned Revenue authority at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **24-11-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
