Note :- (5) The SC/ST candidates included in the Probability List are required to produce Community Certificate issued by the competent Revenue authority not below the rank of Tahasildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SC/ST/DD dt.26/09/2009 issued by the Revenue authority concerned at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **06-01-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
