**NOTIFICATION**

The following is the Ranked List of candidates for selection to the post of DRIVER GR.II(LDV) DRIVER CUM OFFICE ATTENDANT(LDV) (1st NCA HINDU NADAR) -on Rs. 18000 -41500/- in Various Department in Thrissur District, found suitable by the commission and arranged in the order of merit on the basis of OMR Test held on 17/08/2021 and Practical Test held on 22/04/2022 for recruitment against the NCA Vacancies for HINDU NADAR community. This NCA Ranked List is brought into force with effect from 22/06/2022 and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates, belonging to Hindu Nadar community during currency of the Mother Ranked List Published on 06.02.2018 (Category No. 016/2014) or three years from the date of Publications of this NCA Ranked List which ever is earlier.

**NOTE I:**

According to the existing procedure, revaluation of Answer script is not allowed. But Answer script will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commissions website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from along with prescribed fee of Rs.85/- (Rupees Eighty Five Only) under the Head of Account 0051-PSC -105 State PSC 99 -Examination fee addressed to the District Officer, Kerala Public Service Commission, District Office, Thrissur -680020. Application submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of publication of the Ranked List in the official website of the Commission (on or before 11/08/2022). The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

**NOTE II:**

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- (Rupees Three hundred and thirty five only) in any of the Treasuries in the State (Head of Account "0051- PSC-800 State PSC – 99 other receipts"). The duly filled up application in the prescribed form (available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to The District Officer, KPSC District Office, Thrissur – 680020 within 45(forty Five) days from the date of publication of the Ranked List in the official website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of the OMR Answer sheets invalidated due to any defects will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is 11/08/2022. Applications received after the prescribed date will not be entertained.

**NOTE III:**

The entries put in **column (5)** are based on the Community specified by the candidates in their application form and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Thrissur - 680020 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE IV:**

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within **15 days** from the date of publication of Ranked List in the official website of the Commission will be honored against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the Last date of receipt of requisition, based on which he/she is to be advised.

**NOTE V:**

Since a common OMR Test with common candidates was conducted for this post, the mark awarded to the candidates included in the Ranked List and mark of OMR Test and grade mark of Practical Test relating to all candidates appeared for the Practical Test will be published only after the publication of entire Ranked List (including NCA Notification) which will be finalized on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalized on the basis of the common test.

**NOTE VI:**

The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalization of Ranked Lists ,included in the common test held on 17.08.2021.
