Note :- (4) Candidates included in the Short List should be present in person for Physical measurement and Physical efficiency test. Date, Time and Venue of Physical measurement and Physical efficiency test will be intimated through SMS and Profile message. The Shortlisted candidates should download their Admission Tickets for the above test from the official website' www.keralapsc.gov.in' of Kerala Public Service Commission and appear for the test with necessary documents..

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who qualify Physical Measurement and Physical Efficiency Test are required to produce Community Certificate issued by the Revenue authority not below the rank of a Tahsildar along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the Main OMR Test held on **20-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER II(1)2042/2022/EW dated 20/07/2022.
