The shortlisted candidates should download their Admission tickets for the above test from the official website "www.keralapsc.gov.in" of Kerala Public Service Commission and appear for the test with necessary documents.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO (P) No 81/09/SCSTDD dated.26/09/2009 issued by Village Officer, those belonging to SC/ST are required to produce Community Certificate (in Form III/Digitally signed) issued by the Revenue authority not below the rank of Tahsildar and those belonging to EWS category are required to produce EWS certificate in the format prescribed vide GO(MS)No 02/2020/P&ARD dated 12/02/2020 along with other relevant documents at the time of OTR verification on qualifying the Physical Measurement & Physical Efficiency Test and Swimming Test.

Note :- (7) Copy of answer scripts of the Main OMR Test held on **13-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
