Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked after the publication of the Rankedlist. Detailed instructions will be published in the Rankedlist to be published for the post.

Note 7. Copy of answer scripts of the OMR Test held on 13-03-2022 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
