Note :- (5) Dependants of Ex-Service Personnel/Defence Service Personnel should submit the certificate in proof of the relationship of the Applicant with the Defence service personnel, issued by the Tahsildar as and when called for and in the absence of such certificate from the Tahsildar, a certificate obtained from the Commanding Officer concerned proving the relationship of the Applicant with the Defence Service Personnel with his Name, Rank in Military and Address in Military duly recorded, shall be submitted.

Note :- (6) Copy of answer scripts of the OMR Test held on 29-07-2021 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
