The following is the list of candidates for selection to the post of **Cook (First NCA LC/AI)**, on Rs. 16,500-35,700 /in **Scheduled Caste Development Department in Palakkad District (Cat.No..185/2019)** based on the marks obtained in the **OMR Test held on 17-07-2021** and arranged in the order of merit for recruitment against the NCA vacancies for **LC/AI** community. This Ranked List is brought into force with effect from **09.12.2022** and will be valid till the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to **LC/AI** community during the currency of the Mother Ranked List published on 19-09-2017 (Cat No. 566/2013)

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the **District officer, Kerala Public Service Commission, Distict office Palakkad -678001**. Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Approval of the Ranked List (on or before 04/02/2023.....). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the Prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the **Distict officer, Kerala Public Service Commission, District office Palakkad - 678001** within 45(Forty Five) days from the date of approval of the Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 04/02/2023 Applications received after the prescribed date will not be entertained.

NOTE (3) :- The entries put in column (5) are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the District Officer, KPSC, District Office, Palakkad-678001 within one month from the Date uploaded in the commission's website of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List

NOTE (4) :- "The candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances." The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office seal along with a notarized affidavit and a self attested copy of the ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and a self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy based on which he/she is to be advised .

NOTE (5) :- Since a common OMR Test with common candidates was conducted for this post, the mark awarded to the candidates included in the Ranked List and mark of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List which will be finalized on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalized on basis of the common test.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list included in the common test.
