Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) The shortlist is prepared based on the details furnished by the candidate in the application and subsequent claims will not be entertained at any stage.

Note :- (4) The candidates who have secured **47.33 (forty seven (point) three three)** marks and above are included in the Main List and requisite marks have been lowered to the extent necessary in respect of supplementary lists.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes who are included in the Short List who are required to produce Non Creamy Layer certificate as per GO(P) No.81/09/SC/ST/DD dated: 26/09/2009 shall produce the same along with other documents at the time of OTR Verification . Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regards such candidates in the supplementary lists of other backward classes, their register numbers will be deleted from the short lists without further notice,if they fail to produce the Non Creamy Layer Certificate.SC/ST candidates included in the list are required to produce Community Certificate obtained from the Revenue authorities not below the rank of Thahasildar ,EWS certificate in the case of EWS candidates issued by the Revenue authority and Differntly Abled candidates are required to produce Disability certificate along with other documents mentioned at the time of OneTime Verification of original documents issued to produce before Kerala Public Service Commission.

Note :- (8) Copy of answer scripts of the OMR Test held on **26-04-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates who appeared for the OMR test have been invalidated for selection to this post.(Refer to Notification No : ER I(3)2537/2022/EW dated 27/07/2022)
