Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed.

Note :- (7) Candidates belonging to Other Backward Classes who are included in the Short List who are required to produce Non Creamy Layer certificate as per GO(P) No.81/09/SC/ST/DD dated: 26/09/2009 shall produce the same along with other documents at the time of OTR Verification . Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regards such candidates in the supplementary lists of other backward classes, their register numbers will be deleted from the short lists without further notice,if they fail to produce the Non-Creamy Layer Certificate.SC/ST candidates included in the list are required to produce Community Certificate obtained from the Revenue authorities not below the rank of Thahasildar and Differntly Abled candidates are required to produce Disability certificate along with other documents mentioned at the time of OneTime Verification of original documents issued to produce before Kerala Public Service Commission.

Note :- (8) Image of tabulation sheet and answer scripts of the Descriptive Test held on 07-07-2021 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked list.No answer scripts of candidates who appeared for the Descriptive test have been invalidated for selection to this post.( Refer to Notification No : ER I (3)3421/2021/EW dated 20/04/2022 )
