Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be published in due course.

Note :- (6) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Shortlist without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 and SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **21.06.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VII(1) 3842/2022/EW dated 01.11.2022.
