NOTE (1) :- The Ranked List shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Candidates from the Ranked List will be advised against the pending vacancies reported to the Commission for Special Recruitment from Scheduled Tribes(Adivasi only) and also against the vacancies reported during the currency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

NOTE (2) :-Since an additional OMR Test(Tamil/Kannada medium) is proposed to be conducted for the same selection , the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates will be published only after the publication of entire Ranked List which will be finalised .

NOTE (3) :-The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the entire Ranked List for all the posts finalized on the basis of the common test.

NOTE (4) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)** under the Head of Account **0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the District Officer, Kerala Public Service Commission, District Office, Kottayam-686004**. Applications submitted in any other manner will not be considered. A period of **45 (Forty Five)** days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission(on or before **16.02.2023**). The candidates can avail only one chance after the Approval of the Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (5) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : **0051 - PSC - 800 - State PSC -99-Other Receipts**). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission District Office, Kottayam-686004** within **45 (Forty Five) days** from the date on which the Ranked List is uploaded in the website of the Commission . A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own. Legal proceedings will be initiated against those who do so. The last date for receipt of applications is **16.02.2023**. Applications received after the prescribed date will not be entertained.

NOTE (6) :-The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (7) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the entire Ranked List.
