Note :- (6) Candidates included in the Short List are required to produce Community Certificate (in from III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette in case of SC/ST, Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in case of other reservation community at the time of Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **22-01-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
