NOTE (1) : According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission`s website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of Rs.85/ (Rupees Eighty Five Only) under the Head of Account 0051 PSC 105 State PSC 99 Examination Fee addressed to The District Officer, Kerala Public Service Commission, District Office, Palakkad- 678 001. Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this ranked list is uploaded in the Commission's website ie on or before 03/03/2023. The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (2) : Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/ (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : 0051 PSC 800 State PSC 99 Other Receipts). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to The District Officer, Kerala Public Service Commission, District Office, Palakkad 678 001 within 45 (Forty Five) days from the date on which this ranked list is uploaded in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is 03/03/2023. Applications received after the prescribed date will not be entertained.

NOTE (3): Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer sripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (4) : **The candidates who wish to relinquish their claim for advice from the Ranked List shall make the same in the format prescribed by the Commission. The format is available in the official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances.** The request for relinquishment addressed to the District Officer, Kerala Public Service Commission, Palakkad received within 15 days from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised. post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer sripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (5) : The A part and B part of OMR scripts will be destroyed after completing a period of 6 months from the date of finalisation of the last Ranked list included in the Common test.
