Note :- (8) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P)No.81/09/SC/ST/DD dated 26/09/2009 at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **07-05-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (10) No answer scripts of candidates attended the OMR Test held on 07/05/2022 have been invalidated. (Refer the Invalidation Notification vide No:ER II (1)2749/2022/EW dated 31/10/2022).
