Note :- (6) Candidates included in the Probability List are required to produce NCLC in the case of other backward communities and /Community Certificate in the case of SC/ST candidates and EWS candidate should produce EWS certificate issued by the Revenue authority along with other documents mentioned at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
