Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Community Certificate (in Form III) issued by the Revenue Authority not below the rank of tahasildar as specified in Kerala Gazette in the case of SC/ST candidates, Non-Creamy Layer certificate as per GO(p) No. 81/09/SC/ST/DD dated 26/09/2009 issued by the concerned Revenue Authority,in the case of other reservation communities.Those who have claimed for EWS reservation are required to produce EWS certificate as per GO(MS) No,2/2020/P& ARD dated 12/02/2020.

Note :- (7) Copy of answer scripts of the OMR Test held on **25-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ERVII(3) 1580/2022/EW dated 07/06/2022
