Note :- (6) SC/ST candidates included in the Short List are required to produce Community Certificate in Form III/digitally signed and candidates belonging to other reservation groups are required to produce Non Creamy Layer Certificate as per G.O(P) No 81/2009/SC/ST/DD dated 26.09.2009 , as applicable issued by the Revenue authority at the time of OTR Verification.
