Note 6. Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26/09/2009 along with other documents at the time of OTR Verification.

Note 7. Copy of answer scripts of the OMR Test held on **26.02.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
