NOTE (1):- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account **0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the District Officer, K.P.S.C District Office, Pattom P.O. , Thiruvananthapuram-695004.** Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Uploading of the Ranked List in the official website of Commission (on or before **16.03.2023**). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (2):- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission website www.keralapsc.gov.in along with the original chalan should be submitted to the **District Officer, K.P.S.C. District Office, Pattom P.O., Thiruvananthapuram- 695004** within 30(Thirty) days from the date of uploading of the Ranked List in the official website of Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **16.03.2023** Applications received after the prescribed date will not be entertained.

NOTE (3):-The candidate who wish to relinquish their claim for advice from the ranked List shall submit an application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in receipt of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notaized affidavit and self attested copy of an ID Proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the RankedList. After the publication of the RankedList, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (4):- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the common test.

NOTE (6) :- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked list and the marks of OMR test relating to all candidates appeared for the test will be published only after the publication of the entire Ranked Lists (including NCA Notifications).
