Note :- (6) Candidates included in the Short List are required to produce Community Certificate (in form III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette in case of SC/ ST & Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD date 26.09.2009 issued by the concerned Revenue Authority in case of other reservation communities at the time of verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **15-06-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VII(3)3841/2022/EW.
