Note :- (6) Candidates included in the Short List are required to produce Non-Creamy Layer Certificate in the case of Other Backward Communities ,E W S Certificate in the case of Economically Weaker Communities ,Community Certificate in the case of SC/ST candidates issued by the Revenue authority and Differently abled candidates are required to produce disability certificate concerned at the time of OTR verification.

Note :- (7)Copy of answer scripts of the OMR Test held on **07.11.2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
