Note :- (6) **SC/ST** candidates included in the Short List are required to produce **Community Certificate (in form III/ Digitally signed certificate)** and candidates belonging to **other reservation communities** are required to produce **Non Creamy Layer Certificate** as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned **Revenue authority** at the time of **OTR Verification**.

Note :- (7) Copy of answer scripts of the OMR Test held on **27-11-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of no Candidates are invalidated as per Invalidation Notification No: **ERVII(3)340/2022/EW** dated **06/04/2022** .
