Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to to produce Non Creamy Layer Certificate issued by the Village officer as per GO(P) No 81/09/SCSTDD dated 26/09/2009 , Scheduled Caste/Scheduled Tribe candidates included in the Short List are required to produce Community Certificate (in form III/digitally signed) issued under Rule 4 of Kerala (SC/ST)Regulations of issue of Community Certificate rules 2002 by the Revenue authority not below the rank of a Tahasildar and candidates belonging to Economically Weaker Section category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of One Time Registration Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **22-02-2022** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
