Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification before Interview. **Date,time and Venue of OTR Verification & Interview will be intimated through SMS and Profile message.**

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the rank of Tahsildar along with other documents at the time of OTR verification.

Note :- (9) Copy of answer scripts of the OMR Test held on 02-04-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VII(3)2502/2022/EW dated 29.07.2022.
