Note :- (7) Copy of answer scripts of the OMR Test held on **13-04-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : ERII (3)2520/2022/EW(8) dated 23/07/2022
