Note :- (5) Candidates qualifying the Swimming Test are required to submit Medical certificate in the prescribed format at the time of One Time Verification.

Note :- (6) Candidates included in the Short List, qualifying the Swimming Test are required to produce Community Certificate (in Form III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette in case of SC/ST , Non Creamy Layer Certificate as per G.O (P) No. 81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in case of other reservation communities and those who have claimed for EWS reservation are required to produce EWS Certificate as per G.O (MS.) No. 2/2020/P &ARD dated 12.02.2020 at the time of One Time Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **13.03.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
