**NOTE (1) :-** The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

**NOTE (2) :-** According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked to see that all the answers are valued and there is no mistake in the totalling of the marks. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance after the Approval of Ranked List. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from. Application submitted in any other manner will not be considered. The application for rechecking, along with original chalan receipt for the prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)** under the **Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee** addressed to **the District Officer, KPSC District Office, Alappuzha - 688 001** should reach the office on or before **15.04.2023**. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Applications for rechecking received from the candidates whose Answer scripts have been invalidated will not be considered.

**NOTE (3) :-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** in any of the Treasuries in the State (**Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts**). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to **the District Officer, KPSC District Office, Alappuzha - 688001** within 30 (Thirty) days from the date of upload of the Ranked List in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **15.04.2023** Applications received after the prescribed date will not be entertained.

**NOTE (4) :-** The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to **the District Officer, KPSC District Office, Alappuzha - 688001** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (5) :-** Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal alongwith a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of the ID proof, received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised. The candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission to **the District Officer, KPSC District Office, Alappuzha - 688 001**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances.

**NOTE (6) :-** The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the Common Test.

**NOTE (7) :-** Those candidates who claimed General Nursing and Midwifery/B. Sc (Nursing) as higher qualification for the post are provisionally included in the list and their Inclusion in the list and any appointment made shall be subject to the result of OP(KAT) 253/21 & SLP(C) No.13242/21.

**NOTE (8) :-** Since a common OMR test was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists which will be finalised on the basis of the common test.
