Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/Digitally signed) issued by the concerned Revenue authority not below the rank of Tahsildar and candidates belonging to Other Reservation Groups should produce Non Creamy Layer Certificate as per GO(P) No. 81/09/SC/STDC dated 26/09/2009/ EWS certificate as per GO (MS) No. 2/2020/P&ARD dated 12/02/2020 issued by village officer at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **05-09-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : .XVI(i)4674/22/EW dated 30/12/2022.
