Note :- (4) Candidates included in the Short list should present and produce in person an original ID proof, Medical Certificate as per Gazette Notification and recent admission ticket issued for Physical Measurement and Physical Efficiency Test. The admission tickets can be downloaded before the Physical Measurement and Physical Efficiency Test. Date, Time and Venue of Physical Measurement and Physical Efficiency Test will be intimated through Profile Message and SMS.

Note :- (5) The Physical Measurement of candidates will be taken at the time of Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency Test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer along with other documents at the time of OTR verification and a **Medical Certificate as per Gazette Notification**.

Note :- (9) Copy of answer scripts of the OMR Test held on **21/03/2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
