### NOTIFICATION

The following is the list of candidates for selection to the post of **CONFIDENTIAL ASSISTANT Gr. II (NCA-ST)** on **Rs. 20,000-45,800/-** in **VARIOUS DEPARTMENTS IN PATHANAMTHITTA DISTRICT**, interviewed and found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancies for ST. This NCA Ranked List is brought into force with effect from 20/04/2023 and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to ST community during the currency of the Mother Ranked List published on 23/05/2016 (Cat. No.130/2012) for this post.

**NOTE (1) :-** According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to **the District Officer, Kerala Public Service Commission District Office Pathanamthitta**. Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Publication of the Ranked List (on or before 23/05/2023 ). The candidates can avail only one chance after the publication of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

**NOTE (2) :-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to **the District Officer, Kerala Public Service Commission District Office Pathanamthitta** within 30 (Thirty) days from the date of publication of the Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 23/05/2023. Applications received after the prescribed date will not be entertained.

**NOTE (3) :-**The candidates who wish to relinquish their claim for advice from the RankedList shall submit an application in the format prescribed by the Commission to **District Officer, Kerala Public Service Commission District Office,Pathanamthitta**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

**Note (5):-i)** Since a common Dictation and Transcription test with common candidates was conducted to this post, the mark awarded to the candidates included in the Ranked List and marks of interview relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notifications if any) which will be finalized on the basis of the common test.

ii) The result of rechecking of OMR answer scripts will be initiated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalized on the basis of the common test.

**Note (6):-**The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of last Ranked list included in the common test.
