Note :- (4) The Short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce NonCreamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. EWS Certificate issued by the Revenue authority should be produced by the candidates belonging to Economically Weaker Sections at the time of OTR Verification. **Date, time and venue of OTR Verification will be published shortly.**

Note :- (8) Copy of answer scripts of the OMR Test held on 29/10/2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VIII(2) 4890/22/EW dated 01/03/2023.
