Note :- (7) Candidates belonging to Other Backward Classes, included in the list are required to produce Non-Creamy Layer Certificate as per G.O (P) No. 81/2009/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulation of issue of Community Certificates, Rule 2002, issued by the Revenue Authority not below the rank of Tahsildar alongwith other documents at the time of OTR Verification
