Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate issued by the Village officer as per GO(P) No 81/09/SCSTDD dated 26/09/2009 ,Scheduled Caste/Scheduled Tribe candidates included in the Short List are required to produce Community Certificate (in form III/digitally signed) issued under Rule 4 of Kerala (SC/ST)Regulations of issue of CommunityCertificate rules 2002 by the Revenue authority not below the rank of a Tahasildar and candidates belonging to Economically Weaker Section category are required to produce EWS Certificate in the format prescribed vide GO(MS)No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OneTime Registration Verification of original documents
