Note :- (6) SC/ST Candidates included in the Short Lists are required to produce Community Certificate (In form III/Digitally signed) issued by the concerned Revenue authority and Candidates belonging to other reservation group should produce Non Creamy Layer Certificate and EWS candidates should produce EWS certificate issued by Village Officer at the time of OTV.

Note :- (7) Copy of answer scripts of the OMR Test held on **27-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
